When holidays fall on a Saturday, the holiday will be treated as a regular Saturday overtime day and when holidays fall on a Sunday, the following Monday will be recognized as the holiday.

^{**}Galveston Locals observe Emancipation Day on June 19 under most of their Memoranda of Understanding. Veteran's Day and Cesar Chavez Day are holidays under Galveston Cruise and premium pay days under remaining Galveston memoranda.

^{***}These are premium pay days. An individual will be paid overtime the regular rate *only if* the individual worked on that day.

Christmas Day and Labor Day are NO WORK DAYS throughout the west gulf. Thanksgiving Day, July 4, and New Year's Day are also NO WORK DAYS on fully automated operations.
