FULLY AUTOMATED WAGE RATES FOR THE 2024-2025 CONTRACT YEAR

The below rates are the current rates for fully automated container vessel operations, fully automated RO/RO vessel operations, and all vessel and barge operations at the Fully Automated facilities.

As of March 14, 2024, there are five fully automated wage tiers. A worker's starting wage tier is determined by their wage tier on October 1, 2024. For each year after, starting October 1, 2025, a worker will increase to the next wage tier if the worker had at least 800 hours in the prior contract year.

For the year October 1, 2024 to September 30, 2025, the following base wages are associated with the new wage tiers. Skill differentials will continue to apply as found below.

WT-0: \$27.00

WT-1: \$31.50

WT-2: \$36.00

WT-3: \$40.50

WT-4: \$45.00
